

And, of course, we could not run the program without the generosity and trust of many **individual, business and foundation donors.**



## IRA Charitable Rollover Extended

Note: The following is provided for informational purposes only and is not intended to serve as legal or tax advice. For specific information about provisions of the Emergency Economic Stabilization Act of 2008 affecting charitable contributions, consult your tax adviser or attorney.

Congress extended the IRA charitable rollover as part of the Emergency Economic Stabilization Act of 2008.

"What exactly does this mean for me?"

This means, according to [www.guidestar.org](http://www.guidestar.org), that a charitable gift made directly from an Individual Retirement Account (IRA) will not be taxed as income as long as:

- the gift is made in 2008 or 2009;
- the IRA holder is age 70½ or older;

- the gift totals \$100,000 or less each year;
- the charity is eligible to receive tax-deductible contributions;\* and
- the withdrawal goes directly from the IRA to the charity.

The donor does not need to itemize his or her taxes to take advantage of the rollover. If the donor does itemize, however, he or she cannot also take the contribution as a deduction.

\*Kismet Rock Foundation is eligible to receive tax-deductible contributions and is not a section 509(a)(3) organization (it is a 501(c)(3) organization).

"I am thrilled to have the opportunity to put my skills to work for Kismet," said Eisele.

students to the art of rock climbing. Chris hopes to focus his contributions to Kismet in the areas of program development, fundraising and media projects. He lives with his wife and three children in North Conway.

Kismet's current board, under the leadership of Wroblewski and newly elected Vice Chair, **Claudine Safar**, extends its sincere gratitude to long-time board member **Cheryl Rocheleau**, whose term recently came to an end. In addition to her governance contributions, Cheryl also spent time as a program volunteer.

For several years, she also organized and hired the live-in staff before each program season.

# Curriculum Notes

Our students describe their time with us as being really fun, but Kismet is distinctive and profoundly effective largely because of the educational aspect of its mission.

There are few things regarding Kismet that I would change but one is that I very much wish that our donors could see our students on the cliff and see their growth within the context of the curriculum. It is, of course, unrealistic to expect every donor to join us while climbing but at least we can share details of our program in an effort to make more concrete our donors' understanding of what we do.

ing anchors on trees at the end of their first day! By the end of week one, our students have not only climbed many routes, but they have an excellent understanding of all basic skills used at the base of top-roped climbs. They are also familiar with communication and anchor transitions on multi-pitch climbs. During the second season, we review skills learned the previous year and then add skills relating to top-of-cliff safety, tree anchors and rappel anchors at the tops of climbs. Thus, by the end of the second year, Kismet students have quite a clear understanding of top-rope systems.

Here are a few notes about our curriculum:



We teach our students one week per summer for four summers. Minus transportation days, this gives our students 24 days of instruction before they graduate. Our teacher-to-student ratio is typically 1:2 and most instruction is hands-on.

The first year is part of the interview process. Plus, our 12-year old students -- many of whom have never been away from home -- are thrown into a radically new environment (socially, culturally, geographically, ecologically, and dimensionally [verticality!]). Thus, it is important that fun and comfort are particularly emphasized during the first year. But in spite of this, our beginners are belaying, climbing, rappelling, tying all of our most commonly used knots, and construct-

The third-year curriculum combines the first two years by first, reviewing previous skills, and then going to new cliffs and having students find and set up their own climbs. We test every student individually.


It's during the fourth year that our students become truly transformed as climbers. This is difficult to explain but this transformation can be seen in students' body language, the ease with which they function with gear, and the confidence with which they carry themselves on the cliff.

When our beginners first arrive they are young, vulnerable and disoriented children. By the end of year three they are still climbing students. By the end of year four, they are climbers -- and I cannot overstate what a joy this transformation is to witness.






